***Written request for schedule change/withdrawal must be received by 5 p.m. on this date to take effect this bi-weekly billing period.

Important Information:

- *First child is considered the one with the most days.
- There is a two-day enrollment minimum. Priority is given to registrations with three days or more.
- Fees are due in advance, on the Monday prior to the week of each bi-weekly billing period. A \$20 billing fee will be assessed for late payments. Payment reminders will be emailed. Payments are not accepted at program sites.
- Fees will not be pro-rated for missed days, school closings, non-school days or holidays, except for winter and spring break weeks.
- Early release days are included in fees for enrolled days and do not require separate registration.
- All day and break programs offered for additional fees and require separate, advanced registration.
- Fee payment options include monthly auto-pay (using VISA or MasterCard), semester prepayment discount and financial assistance for qualifying families, including Wisconsin Shares.
