**Position Summary:** The float program supervisor is responsible for the daily operations of a before school, 4k wrap or summer day camp program. Locations may vary throughout the year. Wisconsin Youth Company operates programs in three school districts: Merton, Kettle Moraine and Waukesha. This individual will be responsible for filling in vacant school year and summer day camp positions. Responsibilities include lesson planning for children in grades 4K-5, managing staff, purchasing program materials, managing a monthly budget, and ensuring program quality standards are met. This individual is also responsible for additional administrative tasks and quality improvement projects as time allows.

- Has completed college-level (or equivalent) courses in Education (early childhood, elementary, or related)
